From the North, South and West:

From 1-39 in Stevens Point, take Hwy 10 East to Lake Road/Amherst Junction Exit. Turn right onto Lake Road. Cross railroad tracks, bearing left at the stop sign. Continue on Lake Road. Turn left at the stop sign onto Lake Emily Road. Camp Bandy is on the left shortly after crossing under the Hwy 10 overpass.

From Hwy 10 East of Amherst:

Exit County Highway B West, turning right (East) towards Amherst. Almost immediately turn left (North) onto County Highway Q. Go approximately 1 mile through a sharp left turn as road becomes Main Street. Continue straight onto Lake Emily Road when CTH Q turns right. Camp Bandy is another 4 blocks ahead on the right.

Notice to Exhibitors

- A separate entry blank must be completed for EACH DOG ENTERED. Please use care in clearly indicating which test(s) per entry.
- **BITCHES IN SEASON WILL NOT BE PERMITTED TO RUN!**
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of Event Hosts.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event hosts, be asked to leave the event site. In such a case, no refund of event fees paid shall be made.
- Owners and their Agents are solely responsible for the presence of their dog(s) at the Test arena. Judges are not required to wait for dogs.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free from internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- No entry shall be refunded if the event of duplicate entries or any other cause beyond the control of the event host after the closing of pre-entries.
- Please bring your own chairs.
- All dogs must be on leash and/or crated at all times.
- No telephone, fax, online entries, or credit card payments will be accepted.
- Return checks do not constitute a valid entry fee. The Trial Secretary will add a \$35.00 collection fee to the amount of the returned check.
- No alcoholic beverages are allowed at the event site, during event hours.

- Please respect the event site grounds and clean up after yourself, your dogs(s) and/or your children to maintain the premises in a clean and tidy condition! Failure to do so can result in removal from the site without refund of entries paid.

AGREEMENT

I certify that I am the actual owner of the dog, or that I am the duly authorized agent of the actual owner whose name I have entered. In consideration of the acceptance of this entry, I (we) agree to abide by the rules and regulations of The American Kennel Club in effect at the time of this event, and any additional rules and regulations appearing in the premium list of this event and entry form and any decision made in accord with them. I (we) agree that the club holding this event has the right to refuse this entry for cause which the club shall deem sufficient. I (we) certify and represent that the dog entered is not a hazard to persons or other dogs. In consideration of the acceptance of this entry and of the holding of this event and of the opportunity to have the dog judged and to win prizes, ribbons, or trophies, I (we) agree to hold the AKC, the event-giving club, their members, directors, governors, officers, agents, superintendents or event secretary and the owner and/or lessor of the premises and any provider of services that are necessary to hold this event and any employees or volunteers of the aforementioned parties, and any AKC approved judge, judging at this event, harmless from any claim for loss or injury which may be alleged to have been caused directly or indirectly to any person or thing by the act of this dog while in or about the event premises or grounds or near any entrance thereto, and I (we) personally assume all responsibility and liability for any such claim; and I (we) further agree to hold the aforementioned parties harmless from any claim of loss, injury or damage to this dog.
