#### Notice to Exhibitors

- A separate entry blank must be completed for EACH DOG ENTERED. Please use care in clearly indicating which test(s) per entry.
- **BITCHES IN SEASON WILL NOT BE PERMITTED TO RUN!**
- Entry fees will not be refunded in the event that a dog is absent, disqualified, excused, or barred from competition by action of Event Hosts.
- It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event hosts, be asked to leave the event site. In such a case, no refund of event fees paid shall be made.
- Owners and their Agents are solely responsible for the presence of their dog(s) at the Test arena. Judges are not required to wait for dogs.
- Exhibitors should follow their veterinarian's recommendation to assure their dogs are free from internal and external parasites, any communicable diseases, and have appropriate vaccinations.
- No entry shall be refunded if the event of duplicate entries or any other cause beyond the control of the event host after the closing of pre-entries.
- Please bring your own chairs.
- All dogs must be on leash and/or crated at all times.
- No telephone, fax, online entries, or credit card payments will be accepted.
- Return checks do not constitute a valid entry fee. The Trial Secretary will add a \$35.00 collection fee to the amount of the returned check.
- No alcoholic beverages are allowed at the event site, during event hours.
