• From I-39 in Stevens Point, take Hwy 10 East (towards Waupaca) to Lake Road/Amherst Junction Exit. Turn right onto Lake Road. Cross railroad tracks, bearing left to stop sign. - ➤ It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Event hosts, be asked to leave the event site.
